### **A. Bid Opening Date**

1. The original bid opening date of Tuesday, February 9, 2021 as declared in the Notice Inviting Bids on page number 6 of the Contract Documents & Specifications is hereby extended by seven (7) days. **The revised date bids must be received by shall be 2:00 PM CST on Tuesday, February 16, 2021.**

### **B. General Note Item 9 in the Construction Plans**

1. General Note Item 9, Measurement and Payment, Section 2 as found in the Construction Plans is hereby revised to read as follows to be consistent with the corresponding General Note as found on page number 117 of the Contract Documents and Specifications.

**“DD6 will withhold a 5% retainage from each pay request.”**

### C. Pre-Bid Meeting Questions

1. **Question:** *Will testing be the responsibility of the Contractor?*

**Answer:** Yes. It will be the Contractor's responsibility to acquire and coordinate with an accredited independent laboratory for all required testing. This service will not be paid for directly, but shall be considered subsidiary to pertinent bid items.

2. **Question:** *General Note Item 9 Measurement and Payment states 3% retainage will be withheld from each payment. Is that correct?*

**Answer:** No. The reference to 3% retainage in the General Notes is a typographical error and will be corrected by Addendum No. 1. Contractor will be paid once per month for work completed to date, less 5% retainage, less any previous payments.

3. **Question:** *Will access routes for each site be provided to the Contractor?*

**Answer:** No. It will be the Contractor's responsibility to determine his/her own access routes. The Contractor shall submit proposed access routes to the District for approval prior to the start of construction.
